In consideration of the rate charged, it is agreed that the contents of each shipment, whether consisting of one or more packages, is not valued at more than \$50.00, and liability of Esquire Express for loss or damage, irrespective of the cause of such loss or damage, including negligence, is limited to \$50.00 unless a greater value is declared and an increased charge based upon such greater valuation is paid. For each \$50.00 of declared value, or fraction thereof, in excess of \$50.00 an extra charge of .50 cents will be charged. In an effort to give Esquire Express the opportunity to protect shipments of high valued items, such as cash and/or negotiable securities, it is hereby agreed that there shall be no shipment of such high value items without first declaring such items at the time the call for service is placed. Should shipper fail to notify Esquire Express., such failure shall release Esquire Express from any liability for loss or damage, irrespective of the cause of such loss or damage, including negligence. If, after due notice to Esquire Express by the shipper, such high valued items are accepted for delivery or pick up, the same limitations of liability based on the declared value shall so apply. Esquire Express will not be liable for loss or damage caused by delay or improperly packed or improperly labeled shipments. Claims regarding loss or damage of any kind must be made in writing within 30 days of such incident. Claims not made within 30 days shall be deemed waived by the shipper. Should any claim in an amount in excess of the foregoing limits of liability be asserted against Esquire Express by a third party for loss or damage to merchandise handled hereunder, the shipper agrees to hold Esquire Express harmless against any such claim irrespective of the cause of such loss or damage, including negligence. Carrier is not authorized to accept special instructions from shipper. No liability is assumed for delay in delivery or for consequential damages of any kind such as loss of income, loss of interest or loss of business opportunity.

A service charge of 1.5% per month (18% per annum) shall be charged on all past due accounts (30 days after invoice date) subject to a minimum service charge of 5.00 per month. In the event it shall be necessary to collect

for the herein above described service, or any part thereof, the purchaser agrees to pay all costs, including reasonable attorneys fees.
